## 1. General description

The HEF4001B is a quad 2-input NOR gate. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess of  $V_{DD}$ .

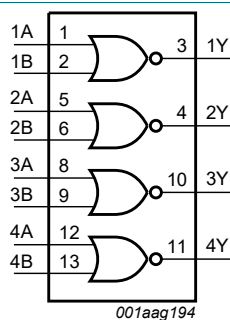


Fig. 1. Functional diagram

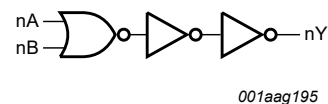
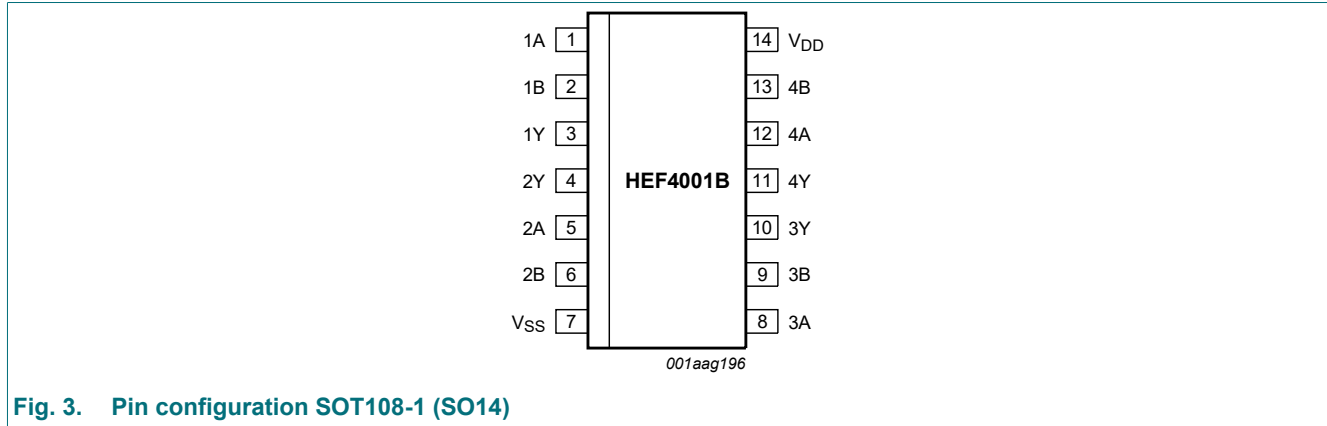


Fig. 2. Logic diagram (one gate)

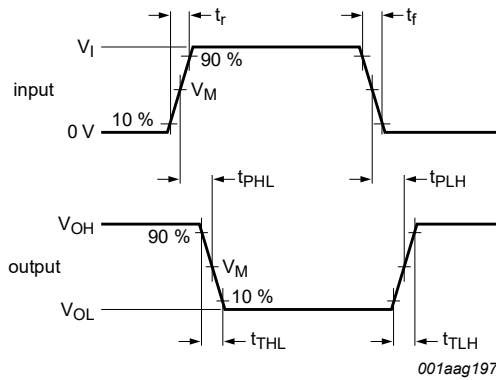

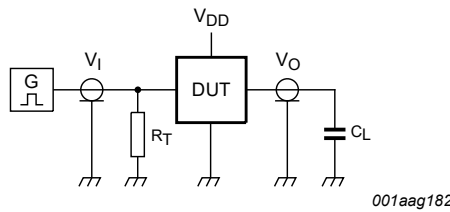

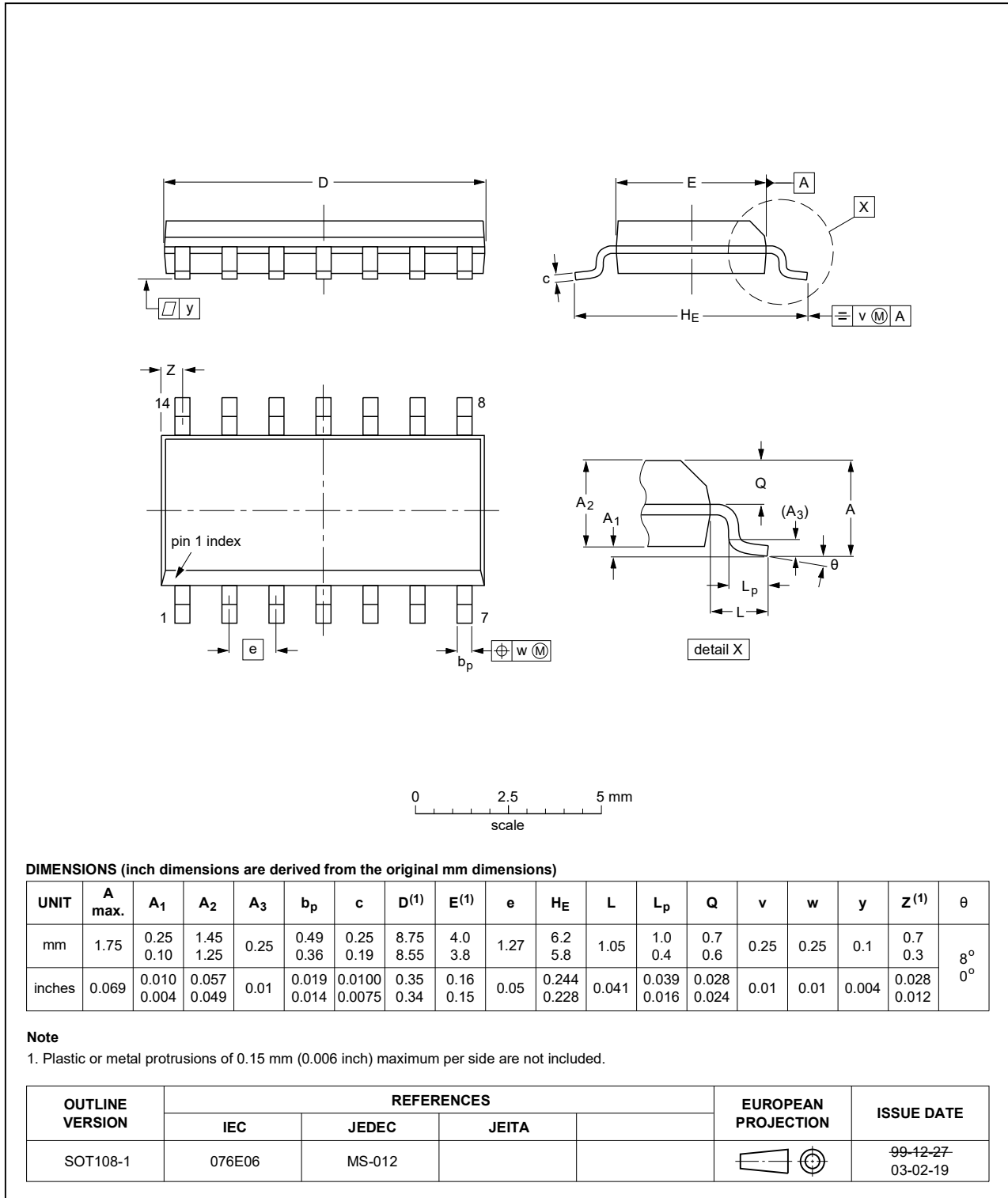


Fig. 6. Package outline SOT108-1 (SO14)
