### Typical Inductance vs. Frequency Characteristics:



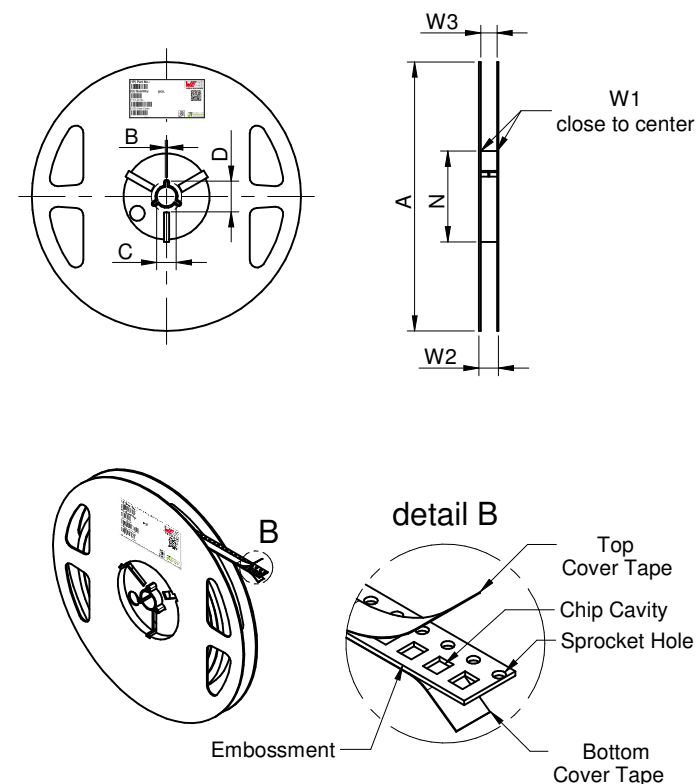
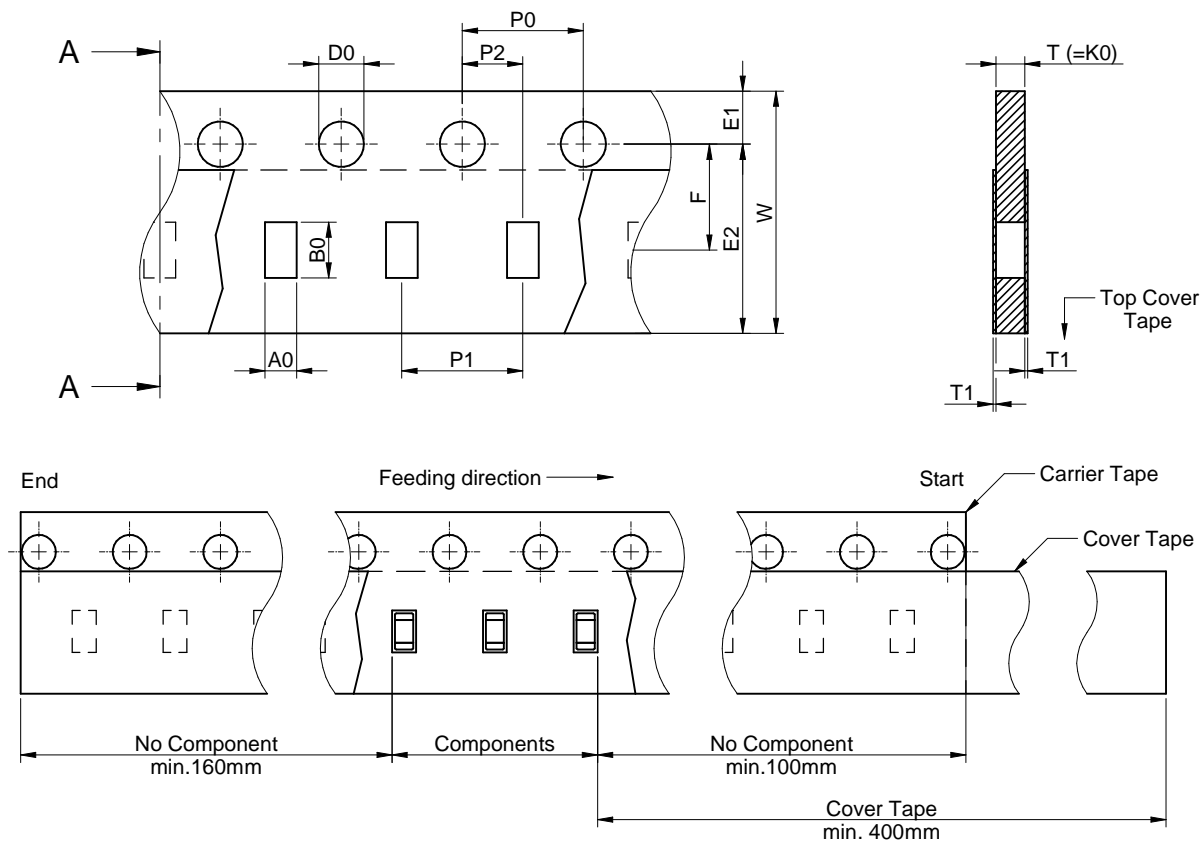



## Storage Conditions:
